

# Who Are We ?

The journey that began on the sidewalk of Britto Road, Karachi in 1980 has gradually blossomed into the largest non-profit health care and blood transfusion services providing free of cost lifesaving quality treatment to patients suffering from chronic blood disorders, mainly Thalassemia and Hemophilia, for over four decades. Our services include medical consultancy, safe blood transfusions, medicine supplies (Iron Chelation medicines to Thalassemia patients and Dry Factors to Hemophilia patients). The Foundation also organizes awareness and prevention programs at national level to prevent Thalassemia and Hemophilia Blood Disorder. This expensive treatment and care expenses are funded through Donations, Zakat, Gifts and In-kind Contributions mostly from its well-wishers, general public and grants from Federal and Provincial Governments.

- To provide awareness and prevention of Thalassemia in Pakistan so as to support decision makers and superior patient management.




## Our Mission

All Centers of Fatimid Foundation are fully equipped for blood collection, preparation of blood products, screening of blood for transfusion transmitted infections, transfusion of blood and blood components, and counseling for prevention of Thalassemia.

# Registration, Affiliation & Exemption

- Fatimid Foundation is registered under the Trust Act 1882 under the amended Trust Deed registered with the Sub Registrar dated December 15, 2002.
- Income of Fatimid Foundation is tax-exempted under clause 66 of Part 1 of the Second Schedule of the Income Tax Ordinance 2001.
- Fatimid Foundation is registered with Federal Board of Revenue as well and files statutory returns on regular basis.
- The Foundation is registered with Pakistan Center of Philanthropy with valid certification.
- The Foundation is registered with Provincial Blood Transfusion Authority.

## External Auditors

Financial Statements of the Foundation are audited by external auditors on annual basis. The Board of Trustees of the Foundation has appointed 'A. F. Ferguson & Co., Chartered Accountants' (a member firm of Price Waterhouse Coopers 'PwC') for this purpose.

## Internal Auditors

In order to ensure transparency and strong internal control system the Board has appointed 'Yousuf Adil, Chartered Accountants', (Ex-Member of Deloitte Touché Tohmatsu Limited) as the Internal Auditors of the Foundation.

## Shariah Advisors

Fatimid Foundation collects Zakat from general public, therefore, to ensure appropriate collection and utilization of Zakat as per the Islamic Jurisprudence, the Board of Trustees has appointed 'Alhamd Shariah Advisors (Pvt.) Limited' as the Shariah Advisors of the Foundation.



# Objective & Break Down of Services

The objective of Fatimid Foundation is to provide lifesaving medical treatment to the mustahiq patients suffering from Thalassemia and Hemophilia on 100% free of cost basis, and work on public awareness for the prevention of these genetic blood disorders.

Breakdown of the services are as follows:

## 1- Blood Management Services

## 4- Transfusion of Blood and Blood Components

- Packed Red Blood Cells (PRBC) are transfused to increase hemoglobin level in Thalassemia major patients
- Fresh Frozen Plasma (FFP) is transfused to treat coagulation factor deficiency disorders
- Platelets are transfused to patients with platelet function defect
- Cryoprecipitate (CP) is transfused to treat patients with Hemophilia A (factor VIII deficiency), Von Willebrand disease and fibrinogen deficiency. Cryosupernatant (CS) is transfused to treat patient with Hemophilia B (factor IX deficiency).





# Description of **Spending on Patients**



Details of our major spending are described as follows:

## **Collection and Screening of Blood**

The Foundation imports blood bags for blood collection. For Serology testing, it uses ECLIA System E601 (ROCHE) and purchases screening kits from ROCHE (Pakistan).

Approximately, 55,000 blood units are collected every year. Last year, collection, screening and grouping costed us around Rs. 105 million (excluding storage, HR and utility costs).

## **Salaries of Para Medical and Support Staff**

For each Medical and Transfusion Center, staff is hired according to the infrastructure and requirement of the Center. Each Center requires a Blood Management Team for collection of blood, a team of technician to manage laboratories and blood storage, and a team of para medical staff including doctors, a pathologist and nurses for laboratories and care of patients. Further, Administration Staff includes Administrator, Accountant, HR and Supporting Staff. Fatimid Foundation has around 390 employees providing their services for this noble cause.

## **Medicines and Supplies**

The Foundation provides free of cost medicines to its patients. These medicines mainly include Iron Chelation drugs for Thalassemia patients and Dry Factors for Hemophilia patients.

Iron Chelation Therapy is an essential drug for Thalassemia patients. Ideal dosage of these drugs through injections costs approximately Rs. 30,000/- while oral therapy costs approximately Rs. 20,000/- per month. Estimatedly, requirement of these drugs for our patients is over Rs. 500 million every year.

## **Laboratory, Medical Equipment and other Fixed Assets**

In order to sustain high standard of services, the Foundation is required to maintain and purchase laboratory material & medical equipment and storage material for blood and blood products and other essential fixed assets on regular basis. The Foundation has assets of Rs. 367 million as on June 30, 2024. Approximately, Rs. 35 to 45 million are spent on the purchase of these assets every year.
